#### **CURRENT POST**

I have been a Consultant Anaesthetist with Nottingham University Hospitals NHS Trust (formerly Nottingham City Hospital NHS Trust) since 1989 and was Clinical Director from 1998-2001. My main field of practice is obstetric anaesthesia, and I also have regular sessions providing anaesthesia for ENT and gynaecological surgery. I have a special interest in the following areas:

- Obstetric anaesthesia
- Regional anaesthesia, including spinal and epidural
- The sick obstetric patient
- Risk management
- Incident reporting and investigation
- Medicolegal and ethical issues, including consent to treatment
- Management of difficult and failed tracheal intubation
- Awareness during anaesthesia

#### MEDICOLEGAL EXPERIENCE

I have had a medicolegal practice for 25 years, and have provided reports in over 800 cases during that time. These encompass all areas of anaesthetic practice and have been largely UK-based, although I have also been instructed in claims relating to care in Ireland, Australia

and Hong Kong. I have only appeared in the witness box on seven occasions to defend a report, as a vast majority of my cases have been settled out of court.

Unusually in medicolegal practice, I have used my experience to generate learning points in an attempt to improve patient safety. To this end, I have lectured worldwide on this topic and recently summarised 22 years of obstetric litigation experience for the annual Bruce Scott lecture for the Obstetric Anaesthetists' Association. These data have now been published in a series of papers in peer-reviewed journals.

I have been instructed by and given expert evidence for the General Medical Council on three occasions.

In 2003 I was awarded a distinction in my Masters in Health Law, for a dissertation on the validity of consent in the labouring woman.

From 2007 – 2009, I held a position as HM Deputy Coroner for Cardiff and the Vale of Glamorgan, having undergone formal coronial training.

I have recently been instructed in a major criminal case involving two anaesthetists charged with manslaughter and their employing Trust charged with corporate manslaughter.
